

# IHBC WALES BRANCH MEETING HELD AT THE INTERNATIONAL PAVILION, THE ROYAL WELSH SHOW GROUND, LLANELWEDD, POWYS ON THE 27<sup>TH</sup> APRIL 2012

## 1. Apologies.

- 1.1. Apologies were received from Tina Lloyd, Jill Fairweather, Edward Holland, Lindsay Cuddy, Gwilym H.Jones, Richard S. Dean, Sue Tomlinson, John Edwards and Trefor Thorpe
- 2. Minutes of the IHBC Wales Branch Meeting held on the 16<sup>th</sup> February 2012 at St Fagans National Museum, Cardiff CF5 6XB
- 2.1. The minutes of the last meeting were read and two corrections were identified 5.1 planned and 9.2 HEG. The remainder was agreed as being a true record of the meeting. (Proposed NM seconded RD).
- 3. Matters arising from the above meeting.
- 3.1. In respect of officer posts. DL informed that she was willing to help if a post was available. The Committee confirmed that her proposal should go to the AGM in November. [action DJ]

## 4. Proposed Online Banking.

4.1. RD updated the meeting on the process and NB & DJ explained why they wished to put the proposal to the meeting. The current system of authorising cheques requires two approved IHBC Wales Branch Committee officers' signatures, while Online Banking allows a single signatory to process payments. In view of this we are suggesting that once Online Banking commences any payments in excess of £200.00 will need to obtain the written approval of two authorised signatories. The suggested method is by email. In addition the meeting proposed an Annual Audit by the IHBC Wales Branch Committee for endorsement at the AGM. (Proposed NM and seconded ALT) [action RD,NB & DJ]

## 5. Heritage Bill for Wales- Branch responses & joint working.

- 5.1. NB confirmed the date for the event at Aberystwyth to be the 25<sup>th</sup> May 2012.
- 5.2. NM confirmed the IFA planned event was vastly oversubscribed by national archaeology heads and the worry is that Welsh members would end up in the minority. Therefore it is proposed that IFA (Wales) will run their own workshop. NB confirmed IHBC will also wish to do the same between now and September.

# 6. ICE Combined Calendar goes digital
