It's worth noting that the membership subscription year for the IHBC is from 1 April to 31 March each year. Subscriptions are due on the 1 April and can be paid by direct debit or by cheque. Cheques should be made payable to the 'Institute of Historic Building Conservation'. All subscriptions must be paid by 1 May. If subscriptions are not paid by 1 July, membership benefits terminate automatically. Membership is formally terminated after that. Therefore, if your membership is terminated, unfortunately this means that you will have to reapply for membership if you fail to renew your subscription in the timescale set out above.

Wed 3<sup>rd</sup> November from 11-12 AM a walk takes place in Glasgow seeking to look at embodied energy saved by adaptive re-use of buildings in part of the Merchant City. Obituary: John Andrew Clare

John had a massive impact on building conservation in Scotland in the 1980s and 1990s. His background was in the Civil Service and, after taking early retirement, he sought to pursue his interest in the historic environment, taking on the role of Secretary for The Scottish Historic Buildings Trust. This was no simple task and the Trust was soon busily engaged in acquiring and seeking to rescue a number of high profile properties, mostly in areas where there was no local trust. SHBT's Office and headquarters in those days was John's own workshop at Saltcoats, Gullane, initially intended as a base for John's other interest in repairing pipe organs. The number of properties that John was directly instrumental in saving is lengthy and includes Strathleven House, Auchinleck, 339 High Street Kirkcaldy (Law's Close), The Spa Pavillion, Strathpeffer, The Hippodrome, Bo'ness, 22 Sandgate, Ayr, Greenlaw Town Hall, Drumlanrig's Tower and Tower Mill, Hawick and Liberton Bank House. He was an astute and persuasive negotiator and brought his diplomatic skills to the Trust, achieving much often in spite of opposition or intransigence from owner's or the seemingly irreversible deterioration of buildings with no apparent future. John was a firm proponent of the theory that there are no problem buildings, only problem owners and he would often repeat this when advising enthusiastic groups, keen to establish their own building preservation trusts. John was also a Director of The Cockburn Conservation Trust and a supporter of the Association of Conservation Officers. He eventually decided to retire for a second time and to the surprise of many he took this decision seriously, withdrawing almost completely from the field that he had once been so prominent in. John died on 27th March this year, aged 76.
